V-shaped' recovery evident: Finance ministry; Nifty tops 13,200

NEW DELHI: The fundamentals of the country's economy remain strong and the 'V-shaped' recovery evident at the halfway stage of FY21 displays the robustness and resilience of the Indian economy against the backdrop of the pandemic, a finance ministry report said on Thursday.

The monthly economic report of the department of economic affairs said the gradual scaling back of lockdowns along with the support of the Atmanirbhar Bharat Mission has placed the economy firmly on the recovery path.

"This is in alignment with economic recovery across the globe reflecting a worldwide pick-up in business and consumer confidence," the report said, adding that the year-on-year GDP contraction of 7.5% in the July-September quarter of FY21 underlies a quarter-on-quarter surge in GD growth of 23%.

India's economy, which bore the brunt of a strict lockdown, staged a smart recovery and contracted 7.5% in July-September quarter, significantly narrower than the record 23.9%



decline in the April-June quarter. Several economists, investment banks and brokerages estimate the full-year contraction to be narrower than previously estimated and have forecast a strong rebound in FY22 as economic activity gathers momentum.

The report said that the sustained improvement in high frequency indicators in October and November ignites optimism of an improved performance in the third quarter of FY21. "The announcement of the third tranche of the Atmanirbhar Bharat package on the eve of Diwali with a multisector focus across the labour market, stressed sectors, social welfare, manufacturing, housing, infrastructure, exports and agriculture, is also a significant step towards faster revival of the economy, restoration of lost jobs and creation of new ones," the report for November said. The report said that the downside risk, however, remains due to the spread of a second wave of Covid-19.

RTGS fund transfer service to be available 24x7 in next few days, says RBI Governor Shaktikanta Das

New Delhi: Reserve Bank of India (RBI) Governor Shaktikanta Das on Friday said that Real Time Gross Settlement System (RTGS), used for large value transactions, will be made available round-the-clock in the next few days. Announcing the December 2020 bi-monthly RBI Monetary Policy decision, RBI Governor Shaktikanta Das said, customers will get round-the-clock availability of Real Time Gross Settlement (RTGS) System soon. Currently, RTGS is available for customers from 7.00 am to 6.00 pm on all working days of a week, except second and fourth Saturdays of every month. RTGS is a financial transaction system, where there is continuous and real-time settlement of fund transfers, individually on a transaction-by-transaction basis. RTGS transactions or transfers have no amount cap. What is RTGS? RTGS is a financial transaction system, where there is continuous and real-time settlement of fund transfers, individually on a transaction-by-transaction basis. RTGS transactions or transfers have no amount cap. What is the minimum amount to be remitted through RTGS? The minimum amount to be remitted through RTGS is Rs 2 lakh with no upper or



maximum ceiling. Since July 2019, RBI stopped levying charges on transactions through NEFT and RTGS, with an aim to promote digital transactions in the country. The central bank has also decided to grant perpetual validity for Certificate of Authorisation (CoA) issued to Payment System Operators (PSOs) to reduce licensing uncertainties. Currently, the RBI issues "on-tap" authorisation under the Payment and Settlement Systems Act, 2007 to non-banks issuing Prepaid Payment Instruments (PPIs), operating White Label ATMs (WLAs) or the Trade Receivables Discounting Systems (TRDS), or participating as Bharat Bill Payment Operating Units (BBPOUs).

Sex toys, huge cache of arms and ammunition recovered from banned extremist outfit's hideout

Ranchi Jharkhand Police has recovered sex toys from the members of the banned extremist outfit Jharkhand Jan Mukti Parishad (JJMP) in Palamu district. In a joint operation against JJMP, Jharkhand Police and a team of the Central Reserve Police Force (CRPF), in wee hours on Thursday, recovered sex toys along with a huge cache of arms and ammunition in Salmadi village of Palamu district. Police are investigating whether the banned extremist outfit is using the sex toys for sexual abuse against men, women or kids. The recovery was made after a brief gun battle with the rebels. An AK-56 assault rifle, a pistol and a few Aadhar cards were recovered from the encounter site. Palamu SP Sanjeev Kumar said that this is the first time in Jharkhand when sex toys have been recovered along with the cache of arms. SP Sanjeev Kumar added that the matter is being investigated from all possible angles to find out more about the seizure of the sex toys and to ascertain the purpose for which the militants were using them.
