Coronavirus: India reports highest single-day jump with 12,881 cases, tally over 3.6 lakh

New Delhi Coronavirus cases in India continued to rise sharply on Thursday as the country reported its highest single-day jump with over 12,000 cases.

However, there is some good news as well. India's recovery rate seems to be improving in comparison to the mortality rate.

Maharashtra continues to be the worst-affected state in terms of rising cases. The state has so far recorded 1,16,752 coronavirus cases, of which 51,935 are active cases.

On Wednesday, Prime Minister Narendra Modi urged to state authorities to save more lives by rapidly expanding testing capacity.

Coffins of 20 soldiers wrapped in tricolour reach 10 states as nation bids farewell to Ladakh bravehearts

New Delhi Awake of grief swept across the country as the mortal remains of the soldiers who laid down their lives fighting the Chinese Army in Galwan Valley in Ladakh were taken to their native places on Wednesday.

Twenty Indian Army personnel, including a commanding officer (CO), were killed in a fierce clash with Chinese troops in the Galwan Valley in eastern Ladakh on Monday night.

In heart-wrenching scenes reminiscent of the aftermath of the 2019 Pulwama terror attack in which 40 CRPF personnel were killed, coffins of soldiers arrived in several states for the last rites with full military honours.

Mumbai In the absence of a large migrant workforce owing to the Covid-19 crisis, MMRDA (Mumbai Metropolitan Regional Development Authority) has advertised vacancies for around 16 thousand workers in various capacities.

The advertisement says that the workforce working under various contractors will be taken care of and shelter would be provided to them. "Water, electricity will be provided for free... Free transport will be provided to the place of work as well."
